The assembled masses approved the chapter's minutes from the October 2023 meeting.

Financial & membership report | Presenter Dave Imler

Dave reported on the addition to the chapter coffers of \$18,303.29 from the Feds, along with donations of \$75 from grateful community members. Expenses for the last period amounted to \$17,627.43 for mileage and the usual outlays for trail projects. Bank balances were:

\$21,707.29 (savings) \$15,728.56 (checking)

Membership stands at 56.

# Trail Projects | Presenter Melissa Green

Melissa reported the chapter's trail statistics to date for 2023:

60 miles of work on deferred trails<sup>6</sup>
126 miles of regular trail maintenance<sup>7</sup>
5,867 volunteer hours
1,795 logs cleared
685 meals prepared for trail workers

Not too bad for a bunch of creaky retired people.

Melissa noted that projects are waiting in the wings for November and December and she will announce them shortly. She also requested feedback about the quality, quantity, and nature of the trail projects from anybody who has opinions/ideas.

Melissa commented that the popular and well-established accounting software, QuickBooks (<a href="https://quickbooks.intuit.com/">https://quickbooks.intuit.com/</a>) has an online version that could support recordkeeping and reporting on trail volunteer hours, mileage, expenses, income, invoicing, etc. Dave noted that he doesn't need it for his purposes as treasurer, but if the software could facilitate grant reporting for Melissa, it's worth looking into. Melissa's proposal is for planning purposes at the moment and she will provide more information at the February 2024 meeting.
